2. Make the labeling changes listed below before you release the product for shipment:

a. For both subject products, revise the Environmental Hazards statement to read as follows:

This product is toxic to fish, birds and other wildlife. Do not apply to any body of water. Do not contaminate water when disposing of equipment washwaters. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.
