The amendment referred to above, submitted in connection with a registration under FIFRA sections 3(c)(7)(a), is acceptable provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed before you release the product for shipment bearing the amended labeling:
  - a) In the "If swallowed" First Aid advice, add "or convulsing" between "unconscious" and "person".
  - b) At the end of the "If inhaled" First Aid advice, add "Get medical attention."
3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section

6(e). Your release for shipment of the product constitutes acceptance of these conditions.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This pesticide may be used only for the formulation of an insecticide. Formulators using this product are responsible for obtaining EPA registration for their formulated product. Refer to Technical Bulletin for formulating and other information.

This technical product may be formulated into end-use products solely for the uses listed below:

Treatment of seeds for the following agricultural crops: barley, broccoli, Brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, oats, radishes, rye, sorghum, spinach, Swiss chard and wheat.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

**STORAGE INSTRUCTIONS:** Storage should be under lock and key and secure from access by unauthorized persons and children. Storage should be in a cool, dry area away from any heat or ignition source. Do not stack over 2 pallets high. Do not move containers from one area to another unless they are securely sealed. Keep containers tightly sealed when not in use. Do not allow material to become wet or store in a damp, humid area. Keep away from any puncture source. Avoid storage near water supplies, food, feed and fertilizer to avoid contamination. Store in original container only. If contents are leaking or material is spilled, follow these steps:

1. Collect and place in suitable containers for disposal.
2. Wash area with soap and water to remove remaining pesticide.
3. Follow washing with clean water rinse.
4. Do not allow runoff to enter sewer or contaminate water supplies.
5. Dispose of waste as indicated below.
