# STATEMENT OF PRACTICAL TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explain that victim has been exposed to parathion and describe his condition. Move patient immediately from the area where parathion is present. ΙF BREATHING HAS STOPPED, start artificial respiration immediately and maintain until doctor sees victim.

IF SWALLOWED and victim is awake (conscious) make him vomit quickly. Have victim drink 1 or 2 glasses of water and induce comiting by touching back of throat with finger. Repeat until vomit is clear. Do not induce vomiting or give anything by mouth to an unconscious persor. Have victim lie down and keep quiet. Get medical attention.

SPLASHED IN EYES, immediately flush eyes with plenty of water for at least 15 minutes and yet medical attention.

IF SPILLED ON SKIN, immediately remove contaminated clothing, INCLUDING SHOES. and wash skin with soap and plenty of water. See doctor immediately.

## POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical attention or they may die.

Some of the signs and symptoms of poisoning are: Headache, nausea, vomiting, cramps, weakness, blurred vision, pin-point pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooling, frothing of mouth and nose, spasms and coma.

### NOTE TO PHYSICIAN

Antidote - administer atropine sulfate in large doses. TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 to 10 minute intervals until signs of atropinization appears. 2-PAM chloride is a pharmacologic antidote and may be administered as an adjunct to, but not a sustitute for, atropine which is a symptomatic and often life-saving antidote. DO NOT GIVE MORPHINE, THEOPHYLLINE, THEOPHYLLINE ETHYLENE DIAMINE (AMINOPHYLLIN) PHENOTHIAZINE OR PHENOTHIAZINE TYPE OF TRANQUILIZERS AS THESE ANTIDOTES MAY PRODUCE ADVERSE EFFECTS ACCENTUATING THE PHARMACOLOGIC EFFECT OF THIS PRODUCT. BEANS: Apply 50 pounds of 10% Granular Parathion per acre broadcast before planting. To control Root Aphids and Mealybugs, incorporate material into top 6 inches of soil. To control Cutworms and Whitegrubs, incorporate into soil immediately after application. To control Symphylans (including garden symphylan), preplant broadcast or apply at ime of planting, incorporate into top 6 to 9 inches of soil. To control wireworms, apply 30 to 40 pounds per acre broadcast before planting, incorporate immediately into the top 4 to 9 inches of soil. Apply at least 1 to 2 weeks before planting. Use lower dosage for mineral soils and higher dosage for organic soils. Reentry interval - 3 days.

<u>BLACK-EYED PEAS</u>: To control Wireworms, apply 30 to 40 pounds per acre broadcast before planting. Incorporate into top 4 to 9 inches of soil. Reentry interval - 3 days.

CANTALOUPES, WATERMELONS: To control Wireworms, apply 30 to 40 pounds per acre broadcast before planting. Incorporate into tcp 4 to 9 inches of soil immediately after application. Reentry interval - 3 days.

CORN: To control Southern Corn Rootworms, apply 10 to 15 pounds per acre. Apply evenly in furrow 1/2 inch below soil surface at time of planting, or apply in a 5 to 7 inch band over row at time of planting or cultivation. To control Cutworms, apply 30 to 40 pounds per acre at time of planting. Incorporate into top 1 to 3 inches of soil immediately after application. To control Symphylans, apply 50 pounds broadcast per acre prior to planting or at time of planting incorporate into top 6 to 9 inches of soil. To control Whitegrubs, apply 30 to 40 pounds per acre broadcast before planting. Incorporate into the top 4 to 6 inches of soil

immediately after application. Use lower dosage for mineral soils and higher dosage for organic soils. Reentry interval - 6 days.

PEANUTS: To control Corn Rootworm larvae apply 20 ro 25 pounds per acre as a row soil treatment at planting of pegging. Incorporate lightly into soil. For Southern Corn Rootworm, apply 20 to 25 pounds per acre as a preplant broadcast soil treatment and incorporate into top 4 to 6 inches of soil, or apply as a band treatment over the fruiting zone just orior to pegging. To control Lesser Cornstalk Borer, apply 20 to 25 pounds per acre in 12 to 15 inch band over row just prior to or after pegging. If applied after pegging apply before irrigation and thoroughly water into the soil. To control Whitegrubs, apply 20 pounds per acre broadcast before planting. Incorporate into top 3 inches of soil. To control Wireworms, apply 30 pounds per acre to the row at time of planting or pegging. Incorporate lightly into soil. Reentry interval - 3 days.

<u>TURNIPS:</u> To control Wireworms, apply 30 to 40 pounds per acre broadcast before planting. Incorporate into top 4 to 9 inches of soil. Reentry interval - 3 days.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STDRAGE INSTRUCTIONS: Storage should be under lock and key and secure from access by unauthorized persons and children. Storage should be in a cool dry area away from any heat or ignition source. Do not allow storage in a damp or humid area. Do not stack bags over 2 pallets high. Move bags carefully so as not to tear or puncture. Do not move from one area to another unless they are securely they are securely sealed to prevent granules from escaping. Keep container tightly sealed when not in use.
