

On new lawns, do not treat until after three mowings. Good grasses may be temporarily discolored. Bermuda, Bluegrass and Zoysia are quite tolerant. Do not use on Centipede or St. Augustine.

Mow lawns 1 to 1.5 inches high before treatment.
