4) Delete under the Use Precautions and Instructions the top two paragraphs to the paragraph dealing with the prevention of contamination of water supplies. The instructions are not applicable to the remaining uses on fence posts, railroad ties, landscape timbers, logs, poles and posts.

5) Delete "Advisements" and delete "such as" under the heading.

6) Delete "Our recommendation" and start with "The use" under the Warranty Statement.

Advisements

To control wood infesting insects such as Ambrosia beetles (Scolytidae), Deathwatch beetles (Anobiidae), False powderpost beetles (Bostrichidae), Old house borers (Cerambycidae) and Powderpost beetles (Lyctidae), treatments may be applied either as coarse sprays or by brushing the product onto targeted surfaces.
