FIRST AID

IF SWALLOWED:

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by a poison control center or doctor.
- Do not give anything by mouth to an unconscious or convulsing person.

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15 to 20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

IF ON SKIN OR CLOTHING:

- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible.

NOTE TO PHYSICIAN: This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine. Malathion is an organophosphate insecticide/miticide.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, aquatic invertebrates and aquatic life stages of amphibians. Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to aquatic organisms in areas near the application site. Do not contaminate water when disposing of equipment washwaters.

This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area.

ORNAMENTALS: For the control of aphids, spider mites (red spider), whitefly, and mealybugs spray with 2.5 lbs. of this product per 100 gals. water. For the control of black scale crawlers, soft brown scale and Monterey pine scale spray with 6 lbs. of this product with 100 gals water. (2 rounded tbsp. to 1 gal. water).
