
WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

- BEFORE selling or distributing any product bearing the final printed labeling AND

GREEN DEVIL SPRAY CONCENTRATE CONTAINING 50% MALAT

The following specific comments pertain to your WPS labeling submission concerning the product cited above:

Add the following User Safety Recommendation to the label in the location shown in Section A on Part I of the Product Worksheet in Supplement Three-A to PR Notice 93-7: "Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing."

In the "Personal Protective Equipment" section on your proposed labeling add the chemical-resistant category statement to state: "Some materials that are chemical-resistant to this product are listed below. If you want more options, follow the instructions for category "appropriate category for your product" on an EPA chemical resistance category selection chart." Remove the incorrect glove requirement.

Delete the crossed-out statements on your proposed label. They are redundant statements or phrases.

Red Spider Mites, Mealybugs, Wooly Aphids, White Flies, Thrips, Bagworms, Rose Leafhoppers, Japanese Beetle Adults - 1 tbsp./gal. of water. Black Scale, Soft Brown Scale, Oyster Shell Scale, and certain others - 1 1/2 to 2 tbsp./gal. of water (*See Caution below).

(*Do not use on Boston, Maidenhair, and Pteris ferns and some species of Crassula).

VEGETABLES: Broccoli, Brussels Sprouts, Cabbage, Cauliflower, Kale, Beans, Peas, Potatoes: Aphids - 1 1/2 to 2 tbsp./gal. of water. Red Spider Mites, Mealybugs, White Flies, Thrips, Bean



Leafhopper, Tomato Leafhopper, Japanese Beetle Adults - 1 tbsp./gal. of water. Do not apply to beans within 1 day of harvest. Do not apply to broccoli and peas within 3 days of harvest, and to Brussels sprouts, cabbage, cauliflower, or kale within 7 days of harvest.

FLEAS ON DOGS AND CATS: 2 tbsp./gal. of water. Wet animal thoroughly. Do not apply more than once a week. ANIMAL QUARTERS: 10 tbsp./gal. of water. Spray kennels, pens, yards, lawns and under houses at the rate of 1 gal. diluted spray per 1000 sq. ft. Remove animals before treatment. Put in fresh bedding after treatment.

HOUSEHOLD PESTS: Roaches, Ants, Spiders, Mosquitoes, Silverfish, Crickets, Clover Mites, Earwigs: 8 tbsp./gal. of water. Using a coarse, wet spray or a paint brush apply to window sills and screens, baseboards, under sinks (especially where pipes come through walls and floors) and dark places where pests hide. Do not contaminate food or utensils.
