STATEMENT OF PRACTICAL TREATMENT

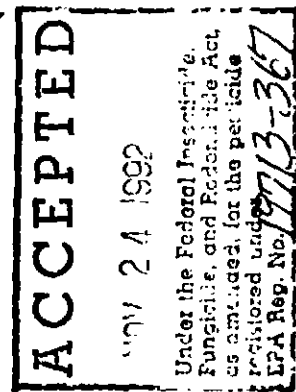

Do not move from one area to another unless they are securely sealed to prevent dust from escaping. Keep container tightly sealed when not in use. Keep away from any puncture source. Avoid storage near water supplies, Food, Feed and fertilizer to avoid contamination. Avoid contamination with acids and alkalis. Store in original containers only. If the contents are leaking or material is spilled follow these steps while wearing protective equipment.

1. Collect and place in suitable containers for disposal.
2. Wash areas with water and soap to remove remaining pesticide.
3. Follow washing with clean water rinse.
4. Do not allow run off to enter sewer or contaminate water supplies.
5. Dispose of waste as indicated below.
