(1) Almonds, Apples, Avocados, Blueberries, Caneberries, Christmas tree plantings, Corn, Cranberries, Filberts, Grapefruit, Grapes, Lemons, Macadamia nuts, Nectarines, Nursery grown deciduous trees, Woody ornamentals and Conifers, Olives, Oranges, Peaches, Pears, Pecans, Plums, Shelterbelts, Sour cherries, Strawberries, Sweet cherries, Turfgrasses and Walnuts.

(2) This product may be used to formulate products for specific use(s) not listed on this label if the formulator, user group or grower has complied with U.S. EPA data submission requirements regarding the support of such use(s).

This product is not to be used for formulation into the following:

- 2) Granular end-use products intended for occupational use.

FIRST AID
