(2) This product may be used to formulate products for specific use(s) not listed on this label if the formulator, user group or grower has complied with U.S. EPA data submission requirements regarding the support of such use(s).

This product is not to be used for formulation into the following:

- Wettable powder end-use products.
- Granular end-use products intended for occupational use.
- 3) End-use products for aquatic use.
