This product is formulated to protect seeds and seedlings against Seed corn beetles, Seed corn maggots, White grubs, Wireworms and certain other soil-borne insects. This product contains effective binding agents to hold the product on the seed during sacking, storing and planting. Apply in a slurry-type treater specifically designed and approved for that purpose.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard (WPS), 40 CFR Part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, greenhouses and handlers of agricultural pesticides. This product may be tank mixed with Vitavax®-200 Flowable Fungicide, Vitavax®-34 Seed Treatment, Captan 4 Flowable Fungicide or Thiram Fungicide at the respective labeled rate. All other tank mixes should be pre-tested to determine physical compatibility between formulations. Observe all precautions and limitations on labeling of all products used in mixtures.

This product is to be used in liquid or slurry treaters.

The U.S. Environmental Protection Agency has set official tolerances for certain pesticide residues. In order that residues on food and forage crops will not exceed established tolerances, use only at recommended rates.

This product will protect seeds and seedlings against damage from Seed corn beetles, Seed corn maggots, White grubs and Wireworms.

DIRECTIONS FOR USE

Only seed of high germination with good vigor should be treated with this product. Poor seed may suffer greater injury. Treat seed not over six (6) weeks before planting. Store treated seed in a cool, dry place until planting, so that excess moisture will evaporate. If seed is stacked when wet, heat may develop which could impair germination.

Note: The purchaser of this product is responsible for ensuring that all seed treated with this product is adequately dyed with a suitable color to prevent its accidental use as food for man or feed for animals. Refer to 21 CFR, Part 2.25. Any dye added to treated seed must be cleared for use under 40 CFR, Part 180.1001.

Labels attached to the treated seed must read: Treated seed should not be used for or mixed with food or animal feed or processed for oil. Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all excess seed by burial away from bodies of water.
