DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

#### PESTS CONTROLLED

This product can control mite and insect pests in the egg stage, including: spider mites, eriophyid mites, armored scales, soft scales, mealybugs, psyllids, whiteflies, aphids, leafrollers, leaftiers, webworms, cankerworms, plant bugs, leafhoppers, and adelgids. This product also will kill other immature forms if the spray covers the insect. The targeted pest must be completely covered with spray.

Oil residue on the surface of treated plants often acts as a feeding deterrent. However, the primary target of application is the pest itself.
