# **Label Changes**

The comments below indicate additional changes that must be made to the label coded "395SP-0810\*Pending" that was submitted to and received by the Office of Pesticide Programs on August 17, 2010.

- 1. In the first sentence of the first paragraph in the "NON-AGRICULTURAL USE REQUIREMENTS" box (page 2, left column), edit the first word ("the") to "The".
- 2. In the first sentence of the "TIMING THE TREATMENT" paragraph, delete "for general use".
- 3. In the first sentence of the paragraph under "USE RESTRICTIONS:" pertaining to "Citrus" (page 3, left column), change "(159 lbs. a.i.)" to "(159 lbs.)" and move it so that it comes between "22.1 gallons" and "of this product". In the same sentence, change "(212 lbs. a.i.)" to "(212 lbs.)" and move it so that it comes between "29.4 gallons" and "of this product". The gallons-to-pounds relationships indicated in this paragraph are more accurate for the formulated product than for the active ingredient, which does not comprise the entire formulated product.
- 4. In the third sentence of the first "WARRANTY—CONDITIONS OF SALE" paragraph (page 3, right column), replace "recommended" with "indicated".

### **METHODS OF APPLICATION**

**Dilute Applications:** Apply specified rate of this product in 100 to 800 gallons of water per acre. Higher spray volumes may be used only for applications to Citrus. See specific directions for applications to Citrus.

Concentrate Applications: Apply specified rate of this product in 50 to 150 gallons of water per acre.

Aerial Applications: Apply specified rate of this product in 10 to 20 gallons of water per acre.

### SPRAY DRIFT MANAGEMENT

### For All Spray Applications:

A variety of factors, including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast) can influence pesticide drift. The applicator and grower must evaluate all factors and make appropriate adjustments when applying the product.

WIND SPEED: Do not apply at wind speeds greater than 15 mph at the application site.

TEMPERATURE INVERSIONS: If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

### **Applications Using Ground-Spray Equipment:**

RELEASE HEIGHT: Apply using a nozzle height of no more than 4 feet above the ground or crop canopy.

WIND SPEED: Do not apply at wind speeds greater than 15 mph at the application site.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

### **Airblast Applications:**

For airblast applications, turn off outward pointing nozzles at row ends and when spraying outer row. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

### **Aerial Spray Applications:**

RELEASE HEIGHT: For aerial applications of agricultural products, do

not release spray at a height greater than 10 feet above the ground top of crops, or above the orchard canopy.

BOOM LENGTH: The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter.

SWATH ADJUSTMENT: When applications are made with a crosswind, the swath will be displaced downwind. The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind. Leave at least one swath unsprayed at the downwind edge of the treated field.

WIND SPEED: Do not apply at wind speed greater than 15 mph at the application site.

DROPLET SIZE: Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

### **PESTS CONTROLLED**

This product can control mite and insect pests in the egg stage, including: adelgids, aphids, armored scales, soft scales, cankerworms, leafnoppers, leafrollers, leaftiers, mealybugs, plant bugs, psyllids, spider mites, eriophyld mites, webworms and whitflies. This product also will kill other immature forms if the spray cover the insect.

Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Dispose of empty container in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Refillable Containers: Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. Dispose of empty container in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
