- f. Under "CROP RECOMMENDATIONS" in the Directions For Use, remove the parentheses from around "cottonwood trees grown for pulp" and place this use site on a separate line.
- 3. Submit one copy of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
