Alfalfa, Asparagus, Barley, Beans (castor, dry, guar, kidney, lentils, lima, mungbeans, navy, pinto and snap), Carrots, Celery, Chicory, Cole Crops (broccoli, brussels sprouts, cabbage and cauliflower), Corn, Cotton, Cottonwood trees grown from pulp, Cucurbits (cantaloupes, cucumbers and watermelons), Durum, Flax, Fruit trees, Grain sorghum, Greens (all collard, kale, mustard and turnip greens), Hops, Mint (peppermint and spearmint), Mustard, Non-bearing and Bearing citrus, Nut trees, Okra, Ornamentals, Onions, Peanuts (Spanish peanuts), Peas (Dry, English, Southern), Peppers (transplant only), Potatoes, Radishes, Rapeseed, Safflower, Soybeans, Sugar beets, Sunflower, Tomatoes, Turf and non-cropland, Vineyards and Wheat.

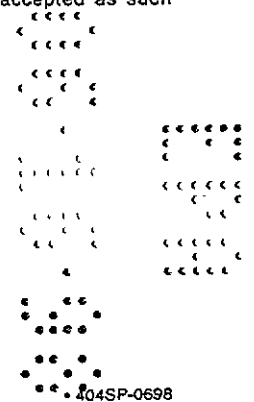
