DIRECTIONS:

This product should be applied as a coarse (large droplet) spray for spot treatment of localized surface areas only.

SPIDER, SILVERFISH, SPIDERS, CRICKETS & EARWIG: Spray on areas where these pests are found or may hide, including dark corners of

& closets, cracks & crevices, along baseboards & door sills & frames, behind & beneath sinks, stoves, refrigerators & cabinets & around garbage cans, plumbing & other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests & points of entry.

Brown Dog Ticks: Apply thoroughly as a spot treatment to infested areas such as pet beds & resting quarters, nearby cracks & crevices, along & behind baseboards, window & door frames & localized areas of floor & floor covering where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product.

Flies & Mosquitoes: Use only on outdoor surfaces. Spray outside surfaces of windows & door frames & other areas where these pests may enter the home. Also spray dark corners & localized resting areas, such as under eaves, porches, partitions & in garages where these insects may congregate. Flies & mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

USE PRECAUTIONS:

Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only as specified on this label.

Do not allow spray to contact food, feedstuffs or water supplies. Thoroughly wash dishes & food handling utensils if contaminated with this product. Remove pets & cover fish bowls before spraying.
