WHEN TO APPLY

LAWN WEED KILLER can be used to control broadleaf weeds at any time during the growing season, but best results are obtained when weeds are growing actively and soil moisture is high, usually the spring and fall. Do not apply when lawn is wet.

AMOUNT TO APPLY

See table below. Avoid contact with flowers, shrubs, trees, or other desirable plants. One application of LAWN WEED KILLER will control most weeds listed. However, certain hard-to-kill weeds such as dock, thistle, knotweed, oxalis, and black medic may require a second application 10 days after the first. Weeds such as henbit, wild garlic, and wild onion should be treated when they appear in early spring and again in late fall.

NOTE: Bentgrass, Carpetgrass, Centipedegrass, Red Fesque, and St. Augustine grass are sensitive to LAWN WEED KILLER and may be temporarily injured. On these lawns use one-half the recommended rate and make 2 applications 10 days apart. Do not apply to non-grass lawns such as Dichondra, Lippia or clover.

MIXING INSTRUCTIONS

Pour the LAWN WEED KILLER into a clean 4 quart or larger container and mix with water in the stated proportions. Pour the mixture into the roller. To aid wetting of roller pour a small amount of mixture on the roller.

MIXING PRECAUTIONS

Do not pour LAWN WEED KILLER directly into applicator. Always premix with water. Do not mix and fill applicator on turf area.

HOW TO APPLY

After placing mixture in roller applicator and wetting roller, roll back and forth several times. Roller is now ready to use. Empty roller after use if stored for more than two weeks.

USE PRECAUTIONS

IMPORTANT Do not allow LAWN WEED KILLER to contact vegetables, flowers, fruit trees, ornamentals or other desirable plants. Do not apply to seeded grass until lawn has been cut at least 3 times.

Avoid double rolling. Especially use caution turning and when towing behind mower.

If unit is too wet or too dry, unscrew center plug and clean air-replacement check.

Applicator should not be parked or stopped on the grass. If unit must be left for short periods of time, it is suggested that it be moved to a non-turf area and stopped with the filler plug in the up position.

Empty roller after using and hang up out of the reach of small children; use the hang-up tab provided on the end of handle.

Do not water or cut lawn within 24 hours after application.

Do not apply when grass is wet.

Do not reseed treated areas for at least 4 weeks after application.

Do not store near seeds, fertilizers, insecticides, or fungicides.

Store in original container.

Do not contaminate water used for domestic or irrigation purposes.

Do not reuse this container. When empty wash thoroughly and destroy.

Keep out of lakes, streams, and ponds.

Apply only as directed on this label.
