For best results apply in the spring after foilage has appeared but before growth has progressed sufficiently to retain more than half of the spray. Applications should be made preferably during periods when moderate rainfall can be expected.

To control certain deep-rooted perennial weeds such as field bindweed, leafy spurge, Canada thistle, Russian knapweed, blueweed, and climbing milkweed, and certain woody vines such as trumpet vine, honeysuckie, kudzu, and smilax, aspply 400 to 550 gallons MOBLEY "BT LIQUID WEED KILLER per acre. To control annual weeds and grasses such as foxtail, ryegrass, wild oats, crabgrass, cheatgrass, bromegrass, ragweed, lambsquarter, puncturevine, orchardgrass, and turkey mullein, apply 75 to 150 gallons MOBLEY "BT" LIQUID WEED KILLER per acre.

To control perennial weeds and grasses such as smooth brome, bahiagrass, bluegrass, redtop, purpletop, quackgrass, broomsedge, aster, dandelion, dog fennel, goldenrod, plantain, and wild carrot, apply 140 to 300 gallons MOBLEY "BT" LIQUID WEED KILLER per acre.

To control Johnsongrass and OTHER HARD-TO-KILL PERENNIAL WEEDS and GRASSES such as Bermudagrass, dallisgrass, nutsedge, Vaseygrass, saltgrass, bouncingbet, dogbane, bracken fern and horsetail, apply 300 to 550 gallons MOBLEY "BT" LIQUID WEED KILLER per acre. Where limited rainfall (usually less than 4 inches) occurs during the active growth period, such as some areas of the West, MOBLEY "BT" LIQUID WEED KILLER will not provide satisfactory control of hard-to-kill, deep-rooted perennial weeds such as Johnsongrass. Use the higher levels of the dosage ranges on adsorptive soils (usually those high in organic matter or carbon).
