ROSES, FLOWERS, SHRUBS AND ORNAMENTALS: Controls Aphids, Leafhoppers, Thrips, Spider Mites, Whiteflies and Mealybugs. Dust lightly on first appearance of insects. Make complete coverage of pests and foliage. Repeat as needed.

VEGETABLES: Dust lightly on first appearance of insects, giving complete coverage. Repeat as needed. Numbers between parentheses () indicate days required between last application and harvest. Pests controlled are listed after crop.

Beans (7), Potatoes (35) — Aphids, Leafhoppers
Cabbage (7), Cauliflower (5), Beets (14), Carrots (10), Radish (10) — Aphids
Cucumbers (7), Summer Squash (7), Winter Squash (3), Melons (3) — Aphids, Thrips, Serpentine Leaf Miners, Mites

Strawberries (5) — Aphids, Spider Mites

Peas (1), Tomatoes (3) — Aphids

Onions (10) — Thrips, Aphids

SOIL TREATMENT (preplant): To control Cutworms, Wireworms and Seed Corn Maggot, mix 1 oz. per 26 sq. ft. into soil to a depth of 6 inches. May be used prior to planting Beans, Broccoli, Cabbage, Brussels Sprouts, Cauliflower, Corn, Lettuce, Melons, Squash, Peas and Tomatoes. **SPECIAL USE:** (Onions) To control Onion Maggot, apply 6 tablespoons per 100 sq. ft. in furrows at row at time of planting.

NUISANCE PESTS (In outside areas): Ants, Roaches, Clover Mites, Earwigs, Spiders and Ticks. Thoroughly dust around garbage cans, foundations, walks and other places insects may hide.
