DESCRIPTION

Best Grass & Weed Killer is specifically designed for quick knock-down and control of general mixed vegetation and such perennial grasses as Johnson Grass, Bull's Grass and Reed Grass (Phragmites) on non-cropped land and industrial sites. Best Grass & Weed Killer may provide season long control of seedlings on treated areas. Soil type, water application and length of growing season will influence the residual control of seedlings. This material is not selective in action and may be toxic to all types of vegetation and may render the entire treated area totally or partially unproductive for one or more years.

DIRECTIONS FOR USE

GENERAL VEGETATION CONTROL: DRY APPLICATION: Apply 1/2 to 2 pounds per 100 square feet. Water thoroughly. Lighter rates should be used only at time of weed emergence on moist soil. The higher rates may be necessary to provide extended residual control. SPRAY APPLICATION: Dissolve 1/2 to 2 pounds of material in 1 to 2 gallons of water and cover 100 square feet. Apply as a contact spray thoroughly wetting all parts of plant, particularly the growing tips. This mixture is usually adequate for young growth up to 6 inches high. The higher rates may be necessary to insure thorough coverage of heavy vegetation or to provide extended residual control.

JOHNSON, BERGUDA, QUACK GRASSES, CANADA WHISTLE, BINDWEED. DRY APPLICATION: Apply 1 to 3 pounds per 100 square feet. WATER THOROUGHLY. The heavier rates may be necessary to provide extended residual control. SPRAY APPLICATION: Dissolve 1 to 3 pounds of material in 1 to 2 gallons of water and cover 100 square feet. SPRAY AS PER GENERAL VEGETATION CONTROL.

NOTICE: Keep spray off cultivated ground or away from "Drip Line" of trees. Keep spray off roots of valuable plants. Avoid using near desirable trees, shrubs or plants. If application is too close to desirable plants, injury may occur as a result of leaching of spray through the soil. Apply when air is quiet. This will lessen the hazard of desirable plant injury due to possible drifting of spray. Do not drain or flush equipment on or near crop or desirable plant areas.
