MIXING AND APPLICATION INSTRUCTIONS

KABAT may be applied by use of a proportional dilution apparatus or preparation of a dilute spray solution. Assure complete coverage by using multi-directional sprayers and tumbling. This concentrated formulation must be diluted with SDA-4 alcohol prior to use. Mix 6 lbs. KABAT Tobacco Protector Concentrate with 91.2 lbs. (13.8 gallons) of SDA-4 alcohol prior to application. Agitate thoroughly. The resulting dilution (containing 5.0% active ingredient) should be applied at a rate of 0.2 lbs. (3.9 fluid ounces) per 1000 lbs. of tobacco. Application should be made directly to tobacco immediately prior to compaction in hogsheads.
