size of the front panel signal word to a minimum of 18 point type. The "KEEP OUT OF REACH OF CHILDREN" and the heading "STORAGE AND DISPOSAL" must be increased to a minimum of 12 point type.

- c. The front panel phrase "FOR REPACKAGING OF AN INSECTICIDE" should also be in a minimum of 12 point type.
- d. From the "BAZARDS TO HUMANS" section delete "or spray mist" as this phrase implies reformulating into another product. (Since this product is crystaline, it should stay that way merely being repacked.)
- e. Revise the following under "HAZARDS TO HUMANS":

"Wash thoroughly with soap and water after handling and before eating or smoking."

(As the present statement now reads, it implies that washing thoroughly is only necessary if you have handled this product with soap and water.)

f. The STATEMENT OF PRACTICAL TREATMENT is not sufficient, furthermore, sticking an object such as a spoon down the victim's throat is specifically prohibited. We suggest the following STATEMENT OF PRACTICAL TREATMENT, however, if your toxicological information suggests otherwise, please submit a draft STATEMENT OF PRACTICAL TREATMENT for prior approval.

"STATEMENT OF PRACTICAL TREATMENT

If swallowed-Call a physician or Poison Control Center immediately.

Drink one or two glasses of water and induce
vomiting by touching the back of throat with
finger. Repeat until vomit fluid is clear. Do not
induce vomiting or give anything by mouth to an
unconscious person.

If inhaled- Remove victim to fresh air. Apply artificial respiration if indicated.

If on skin- Remove contaminated clothing and wash affected areas with soap and water.

If in eyes- Flush eyes with plenty of water. Call a physician immediately."

g. Revise your "STORAGE AND DISPOSAL" statement in accordance with the enclosure. Note: the first line of the present statement is misleading, it instructs the user not to contaminate water, food or feed by storage or cleaning of equipment. Please use the sentence given in the enclosure; this informs the user not to contaminate water, food or feed by storage or disposal of the product!

h. Revise your "ENVIRONMENTAL HAZARDS" section as follows:

"ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Do not discharge in lakes, streams, ponds or public waters unless in accordance with a National Pollution Discharge Elimination System permit. For guidance, contact you regional office of the EPA. Do not contaminate water by cleaning of equipment."

(Note: the way the present statement is written, it indicates that the product can normally be discharged into public waters but that in some cases a permit may be required.)

- i. The sentence "This pesticide may be used only for repacking an insecticide." does not make sense. Revise it to read: "This pesticide may be used only for repacking as an insecticide." (Underscore indicates added text and should not be reproduced on the label.)
- j. Under the "INSTRUCTIONS FOR REPACKING" change "my" to "may".
- 4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA Sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.
