DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

RLCA-W12-0 is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 40 fluid ounces of RLCA-W12-0 per 1000 gallons of water to provide a concentration of 40 RLCA-W12-0 per 1000 gallons, before use in the system, is recommended. Repeat initial slug additions of 1.20 RLCA-W12-0 per 1000 gallons of RLCA-W12-0 employed every 2 to 5 days, or as needed. The amount of bleedoff and the severity of the problem upon the relative amount of bleedoff and the severity of the problem. Slug additions should be made in the sum of RLCA-W12-0 is used in air-washing systems that maintain effective minimum concentrations to its use, systems should be cleaned to remove deposits. An initial slug dose of 21.37 RLCA-W12-0 per 1000 gallons of RLCA-W12-0 is recommended. Repeat initial dosage until control is achieved. Additions of 14.44 to 35.63 fluid ounces of RLCA-W12-0 per 1000 gallons of water should be employed each day. Frequency of addition depends upon the relative severity of the bacterial problem. Slug additions may be made to collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leaking drums should be disposed of. Spills should be absorbed in sawdust or sand and container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of at a government approved waste disposal facility.

CONTAINER DISPOSAL:
