DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use Restrictions

{For Container labels that include premise uses}

- [Except when applying directly to animals], do not allow people or pets to enter the treated area until sprays have dried or vapors, mists and aerosols have dispersed and the treated area has been thoroughly ventilated.
- Do not apply this product in a way that will contact any person or pet either directly or through drift. Keep people and pets out of the area during application.
- Do not remain in treated area. Exit area immediately and remain outside the treated area until aerosols, vapors and/or mists have dispersed.
- Remove pets or animals when spraying animal premises.
- Only spray in well ventilated area.
- Not for use in farm structures or buildings housing food producing animals or poultry or in milk rooms.
- Remove or cover exposed food and drinking water before application.
- Remove or cover dishes, utensils, food processing equipment and food preparation surfaces or wash them before use.
- Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.
- Remove pets, birds and cover fish aquarium before surface spraying.

{For Container labels that include on-animal uses only}

- Not for use on meat or dairy animals, poultry or horses or foals intended for slaughter.
- Do not allow product to contact animal's eyes, nose, mouth or sores during application.
- Do not use on foals under 12 weeks old.
- Do not use on dog, cats, puppies or kittens.

Hold container upright with nozzle pointed away from you and press actuator button, spraying as directed.

TO TREAT HORSES: To protect horses from attacks of stable flies, horse flies, deer flies, house flies, horn flies, mosquitoes and gnats, spray about 3 seconds on each side being careful to spray legs, belly, neck, back and sides. Cover eyes while spraying face or spray on sponge or cloth and apply to face as a wipe. Brushing horse after applying will bring out a bright sheen.

TO KILL AND REPEL FLYING INSECTS IN ANIMAL QUARTERS: Spray in areas where insects congregate at a rate of 1 second per square foot. Direct spray to contact insects for rapid knockdown and kill. Spray around door facings and screens to render area unattractive to insects. This helps to repel insects and prevent entrance into building.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Do not store near heat or open flame.

Disposal: Do Not Puncture or Incinerate!

If empty: Place in trash or offer for recycling if available.

If partly filled: Call your local solid waste agency for disposal instructions.
