#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dilute Pyranha 1-10AC Concentrate just prior to use as follows:

**0.25% Allethrin:** Add 1 part concentrate to 13 parts water

When used as a space spray will control house flies, horn flies, stable flies, horse flies, mosquitoes and gnats.

Add concentrate to water. Mix well. Clean tank frequently to prevent biological growth.

Reseal tank. Set nozzles to deliver 1 ounce liquid per minute. Locate nozzles to cover maximum 2000 cubic ft. space. Set timer to operate two three-minute cycles per 24 hours.

**Container Disposal:** Triple rinse (or equivalent) and offer for recycling, reconditioning, or disposal in approved landfill or bury in a safe place.
