Dear Mr. Jackson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below. A stamped copy of the labeling is enclosed for your records.

1. In the Precautionary Statements section of your label, add the phrase "Causes moderate eye irritation."
2. In the Statement of Practical Treatment section of your label, delete the phrase "if irritation persists" from "Get medical attention..."
3. Change the "petroleum distillates" statement to read "Contains greater than 10% petroleum distillates."
4. Add the following statement to your Environmental Hazards section: "Do not contaminate water by cleaning of equipment or when disposing of equipment washwaters." Further, please update your Environmental Hazards statement as per PR Notice 93-10, and add the required toxicity to fish statement.
5. Delete "Do not treat areas where food crops are growing." This is an end-use product precaution and not appropriate for a manufacturing-use product.
