**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WIPE N' SPRAY has been especially developed for use on horses. It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1 to 2 ounces per head per day gives adequate protection. Apply by either soft cloth or fine spray mist.

**USE TO WIPE ON:**

First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against hair growth. Give special attention to legs, shoulders, shanks, neck, and facial areas where flies are most often seen.

Only a light application is needed. Avoid using an excess amount. Do not wet skin.

After application, brush out thoroughly to bring out bright sheen on the coat.

Repeat daily or as needed.

**USE AS A SPRAY:**

WIPE N' SPRAY may be applied as a fine spray mist to stable area and over and around stabled horses for fast paralysis and kill of flies. Do not wet horse's skin or exceed two ounces per application.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in a cool, dry place. Do not store near heat or open flame.

**Disposal:** Securely wrap original container in several layers of newspaper and discard in trash.

**Container Disposal:** Do not reuse empty container. Wrap container and put in trash.
