d. Expand the instructions for outdoor use by adding the following statements: Direct the diluted spray into tall grass, shrubbery and around lawns where these pests might hover or rest. Apply when the air is still and avoid wetting foliage. Do not apply when wind speeds exceed 10 mph. Do not apply directly to open water. Do not apply within 100 feet of lakes and streams. Do not allow spray treatments to drift to ornamental ponds, pasture lands, cropland, poultry ranges, or water supplies."

e. Under How to apply add the following instructions/precautions for use with Pyranha Spray Master Automatic Space Spray System following directions in the Installation, Operation and Service Guide. Do not install within 3 feet of air ducts. Foods must be removed or covered during treatment. Do not use where people will be continuously exposed. Apply at a rate of 1 ounce of diluted product per 1000 cubic feet of area.

**ENVIRONMENTAL HAZARDS**

**Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**Container Disposal:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

**Dilution/Use Rate:** Dilute before using. Use as a space spray, dilute by adding 1 part of this product to 21 parts of clean water. Mix thoroughly prior to application. Repeat treatments after 1-hour only as necessary to maintain control.

**How to Apply:** For indoor and outdoor applications, apply as a space spray (or area spray) using mechanical (Non-Thermal) spray equipment such as Pyranha SprayMaster Automatic Space Spray System. Adjust spray nozzles to deliver a fine mist to the entire treatment area at a rate of 1 ounce diluted product per 1,000 cubic feet of area. If desired, application can be made with commercially available handheld spray equipment using the same dilution /use rate.

**Indoor Use:** Use as a space spray in horse barns, dog kennels, and zoo animal quarters. Personnel should vacate containment areas (i.e. horse barns, dog kennels) to be treated while treatment is in progress. Treated areas should be thoroughly ventilated prior to re-entry by personnel. Do not use in commercial food/feed handling establishments, restaurants, or other areas where food is commercially prepared, processed or served.

Do not apply this product in horse barns (stables) where horses intended for slaughter or human consumption will be maintained. Do not apply to animals.

**Outdoor Use:** Use as an outdoor area spray for temporary reduction of listed insects on and around homes, patios, tennis courts, pool areas, beach houses, and lawn areas. Do not treat areas where food crops are growing.
