For use on all Eladegram lawns. DO NOT USE ON THESE GRASSES. St. Augustine, Tifgreen and other fine-bladed Bermudas, bertgram, carpetgram, and dichondra.

To prevent crabgrass, toxtail, common chickweed, Johnsongrass, purslane, and other susceptible wood seeds from growing, apply KW Total in late winter, or in spring.




