INSECT SPRAY

New Highly Active Synthetic Pyrethroid

For use in bakeries, food plants, restaurants, schools, hotels, office buildings, hospitals and food handling plants.

Kill flies, mosquitoes, gnats, flying moths (millers), wasps, roaches, waterbugs, earwigs, grain mites, sow bugs, spiders and centipedes.

DIRECTIONS FOR USE

Mosquitoes, Flies, Gnats, Flying Moths (Millers): Close all doors and windows. Direct the spray to all parts of the room. Fill the room with mist, then leave the treated area. Keep room closed for at least 15-30 minutes. Ventilate the room when treatment is completed.

Wasps: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

Roaches, Waterbugs, Earwigs, Grain Mites, Sowbugs, Spiders and Centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings and pipes and sinks, under refrigerators, base boards and storage areas. Spray directly on insects where possible. Repeat as necessary.

CAUTION: KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Do not spray near or toward an open flame. Avoid contamination of feed and foostuffs.

When using this product as a space spray in food processing plants, foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using this product in these areas, apply only when facility is not in operation.

Do not remain in treated areas and ventilate the area after treatment is completed.

This product is toxic to fish. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label. Do not use, pour, spill or store near heat or open flame.

Do not reuse empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place away from water supplies.
