The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1) Add to Directions for Use the following statements:
 - a) "Before spraying in medical care areas, remove all patients. After spraying ventilate area for 2 hours before returning patients."
 - b) "In commercial food handling facilities, cover or remove any food or food processing equipment during application. Do not apply while food processing is underway."
- 2) Add to the Storage and Disposal Section the statement, "Do not contaminate water, food, or feed by storage or disposal."
- 3) Add a footnote to the ingredient statement as follows:

"Contains petroleum distillates"

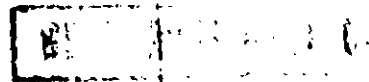

Mosquitoes, Flies, Gnats, Flying Moths (Millers): Close all doors and windows. Direct the spray to all parts of the room. Fill the room with mist, then leave the treated area. Keep room closed for at least 15-30 minutes. Ventilate the room when treatment is completed.

Wasps: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

Roaches, Waterbugs, Earwigs, Grain Mites, Sowbugs, Spiders and Centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings and pipes and sinks, under refrigerators, base boards and storage areas. Spray directly on insects where possible. Repeat as necessary.

STORAGE AND DISPOSAL

Store drum away from sources of flame or heat. Store away from fertilizers, food, or feed. Do not reuse empty containers. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
