**SWIMMING POOLS - FOR NEWLY FILLED POOLS -**

**TO ESTABLISH A CHLORINE RESIDUAL TO DISENFECT THE POOL, ADD 1/2 GALLON OF PRODUCT FOR EACH 15,000 GALLONS OF WATER, REPEAT THE DOSAGE UNTIL A CHLORINE RESIDUAL OF 0.6 TO 1.0 PPM IS ESTABLISHED.**

**FOR DAILY POOL MAINTENANCE -**

**ADD 1 QUART FOR EACH 15,000 GALLONS OF WATER DAILY OR AS NEEDED TO MAINTAIN A CHLORINE RESIDUAL OF 0.6 TO 1.0 PPM. TEST POOL WATER FREQUENTLY WITH A CHLORINE TEST KIT TO MAINTAIN THE DESIRED CHLORINE RESIDUAL. THE POOL WATER SHOULD BE MAINTAINED AT A PH OF 7.2 TO 7.6 AS DETERMINED BY A TEST KIT.**
