User Safety Recommendations

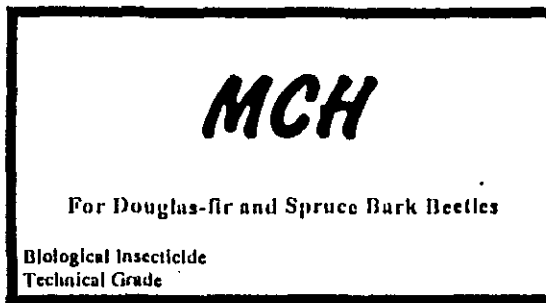

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Manufactured only for formulation into a biological insecticide for end-use products for managing bark beetles in the family Scolytidae. This antiaggregation product is registered only to prevent the infestation of the Douglas-fir beetle (*Dendroctonus pseudotsugae*) and the spruce beetle (*Dendroctonus rufipennis*). End-use products would modify mass attack beetle behavior to forest trees and ornamental or non-commercial trees in urban parks, golf courses, lawns and landscapes. Tree species include but not limited to Douglas-fir, Englemann spruce and other spruce trees.
