The amendment referred to above, submitted in connection with registration under section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Addition of goats to the label is acceptable. However, the statement "not intended for use on food producing animals" must be changed to "Do not use on goats or horses used for meat or milking."
 - b. Submit a new Confidential Statement of Formula using the Form revised in 1985. Under column 14 the lower certified limit for each of the active ingredients must be equal to or greater than the amount claimed on the label. A copy of the revised Form is enclosed for your convenience.
3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Avoid contact with eyes. In case of contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists. For external use on animals only.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Thoroughly wet the entire animal with warm water. Apply just enough shampoo to product a lather.

For best effects on fleas, lice, ticks and keds, allow lather to remain on animals for approximately five minutes before rinsing.

Rinse thoroughly with warm water. May be repeated once or twice weekly.

For use on dog, cats, horses and goats, to control fleas, lice, ticks, and keds. Imparts a clean lustrous shine and hair condition. Promotes manageability of hair coat for good grooming.

STORAGE AND DISPOSAL

Store in original container in cool, locked storage area.

Do not reuse bottle. Rinse thoroughly, wrap in newspaper before discarding in trash.
