Dear Mr. Santerre:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Make the following changes to your label:

a) In the Statement of Practical Treatment/First Aid, please add the following instructions:

"IF SWALLOWED: Drink 1 or 2 glasses of water and induce vomiting by touching finger to back of throat. Never give anything by mouth to an unconscious person. Call a physician.

IF ON SKIN: Wash with soap and water."

2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

Hazards to Humans and Domestic Animals

CAUTION: Avoid breathing of dust when you apply powder. Harmful if swallowed. Avoid contact with eyes, skin or clothing. Keep out of reach of children. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication. Sensitivities may occur after using **ANY** pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

USER SAFETY REQUIREMENTS
<ul style="list-style-type: none"> ■ Wear long-sleeved shirt, long pants, shoes plus socks and household latex or rubber gloves when applying this product. ■ Change clothing as soon as possible after use. ■ Wash the outside of gloves before removing. As with any pesticide product, wash hands thoroughly immediately after handling and before eating, smoking or using the toilet.

Statement of Practical Treatment/ First Aid

IF IN EYES: Flush with plenty of water. If irritation persist, see a physician.

Do not use this product on animals simultaneously or within 30 days before or after treatment with or exposure to cholinesterase inhibiting drugs, pesticides or chemicals. However, flea and tick collars may be immediately replaced.

NOTICE TO PHYSICIAN and VETERINARIAN: Carbaryl is a moderate reversible cholinesterase inhibitor. Atropine sulfate is antidotal.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

How to Use: **For control of fleas, ticks and lice** - Use product only outside or in a well-ventilated area. Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth and genital areas. Rub or brush pet's hair to work dust down to skin. This product should not be applied by children. Do not use on pregnant dogs. Do not use on kittens or puppies under 12 weeks of age. Dust bedding and doghouse using a shaker can or other dust applicator. **Do not repeat applications more than once a week.**

STORAGE AND DISPOSAL

Storage: Store in original bottle in cool, locked storage area.

Disposal: Do not reuse bottle. Empty completely, wrap in newspaper before discarding in trash.
