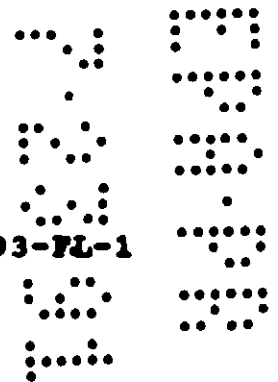

**PRECAUTIONARY STATEMENTS**

**Hazards to Humans and Domestic Animals**

**CAUTION:** Harmful if swallowed. Avoid breathing spray mist. Avoid contact with skin and eyes. In case of accident follow instructions in **Statement of Practical Treatment**. Do not use on meat or dairy animals or horses intended for human consumption. Avoid contamination of food or feedstuffs.

**Physical or Chemical Hazards**

**Statement of Practical Treatment**

- IF SWALLOWED:** Call physician immediately. Do not induce vomiting unless no other treatment is available. Vomiting may cause aspiration pneumonia. Vomiting may be induced by placing finger in back of throat.
- IF INHALED:** Remove victim to fresh air, respire if necessary.
- IF ON SKIN:** Wash promptly with soap and water.
- IF IN EYES:** Flush eyes with plenty of water. Call physician if irritation persists.

**DIRECTION FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SPRAY:** To treat animals and protect them from **Flies, Mosquitos and Gnats**, spray animal thoroughly, being careful to spray the legs, belly, neck and sides. Cover eyes while spraying face. Use 1 to 2 ounces to lightly mist the animal's hair. Do not wet to skin. Repeat treatment as necessary when flies are troublesome. Brushing animal after treatment will give coat a sheen.

**WIPE-ON:** Solution may also be used as a wipe-on treatment. Use soft towel or sponge, dampen with solution and rub on animal's hair, first against the hair and then with the hair to give shine and groomed appearance. Wipe face and neck area carefully for **Face Fly** relief. Repeat as needed.

**STORAGE AND DISPOSAL**

Store in original container away from heat and open flame, in locked storage area.

Do not reuse bottle. Rinse thoroughly, wrap in newspaper before discarding in trash.
