#### PRECAUTIONARY STATEMENTS

##### Hazards to Humans and Domestic Animals

**CAUTION:** Harmful if swallowed, inhaled or absorbed through the skin. Do not breathe dust. Avoid contact with eyes and skin. Wash hands after handling and before eating or smoking. Do not apply to food processing surfaces or use in food processing areas where food is exposed. Cover fish aquariums before use. Keep children and pets off treated carpet and upholstered furniture during treatment and while powder is still visible on their surfaces.

**On Animals:** Do not use on puppies and kittens under twelve (12) weeks of age. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

#### STATEMENT OF PRACTICAL TREATMENT/FIRST AID

**IF SWALLOWED:** Call a physician or Poison Control Center immediately. Induce vomiting by giving victim 1 or 2 glasses of water and touching back of throat with finger. Never give anything by mouth to an unconscious person.

**IF IN EYES:** Flush eyes with plenty of water. Get medical attention if irritation persists.

**IF ON SKIN:** Wash with soap and water.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Shake well before using. Apply to dry surfaces only. Do not wet powder. Apply powder more heavily to areas of flooring or furniture on which the pet spends most time.

**FLEA CONTROL IN CARPETS:** Sprinkle 4 ounces of Carpet Dust for each 100 square feet of carpet to be treated. For best results and even application, brush dust (powder) into carpet lightly with broom. Wait one hour and vacuum (lightly) to remove visible surface powder. This treatment will kill the fleas in the carpet and deodorize at the same time. For maximum efficacy, delay vacuuming for up to 24 hours.

**UPHOLSTERY:** Remove loose cushions. Sprinkle along creases and into corners. Brush lightly to work powder into folds and creases. Vacuum to remove visible powder on surfaces. Do not use on exposed fabric without first testing on a hidden surface for effects on color (staining) or texture. If powder adheres to a spot, brush out and vacuum that area promptly.

**NOTE:** After use, remove filter bag from vacuum, wrap in several layers of newspaper and dispose of in trash collection. Treat pets before their re-entry into room.

**FLEA CONTROL ON PETS:** For best results to kill fleas and ticks on Cats, Dogs, Kittens and Puppies, dust powder liberally over entire body. Rub dust into hair taking care that feet pads and between toes are treated thoroughly. Do not get dust in animals eyes, nose or mouth. Dust sleeping area regularly. Repeat once a week, as needed.

### **STORAGE AND DISPOSAL**

**Storage:** Store in original container in cool, preferably locked, storage area.

**Disposal:** Do not reuse container. Empty completely, wrap in newspaper before discarding in trash.
