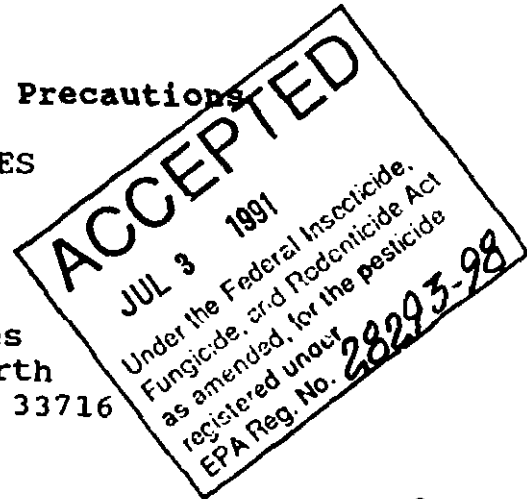

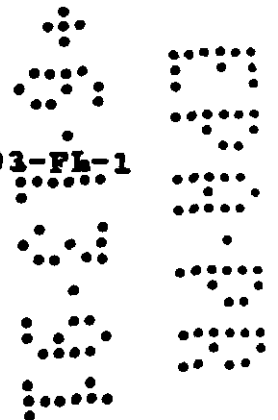

## PRECAUTIONARY STATEMENTS

### Hazards to Humans and Domestic Animals

**CAUTION:** Causes eye irritation. Harmful if swallowed. Avoid contact with eyes or lips. Do not let children rub their eyes if hands have been treated.

### Physical Hazards

**EXTREMELY FLAMMABLE:** Contents under pressure. Do not use near fire, heated surfaces, sparks or flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. May damage some plastics, varnished or painted surfaces. May be used on Nylon, Orlon, wood or cotton. **DO NOT USE** on Rayon, Spandex or Dynel.

### Statement of Practical Treatment

**IF IN EYES:** Flush eyes with plenty of water. Get medical attention if irritation persists.

**IF SWALLOWED:** Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Remove protective cap, and spray from a distance of 8-12 inches from surface to be protected. Slightly moisten surface-saturation is not necessary. Use slow sweeping motion.

For Exposed Skin Areas to repel flies, gnats and mosquitoes: Use as directed above. **AVOID CONTACT WITH EYES OR MOUTH.** For treating face, spray in palm of hand, rub palms together and rub on face.

For Clothing to repel ticks, fleas and chiggers (See Caution): Make liberal application along all openings of the clothing, such as inside the neck band, the fly and cuffs of trousers, tops of socks, eyelets of shoes and areas of clothing which may contact the ground, weeds or other growth.

### STORAGE AND DISPOSAL

**Storage:** Store in original container in cool, locked storage area away from heat and open flame.

**Disposal:** Replace cap and discard containers in trash. Do not incinerate or puncture. Securely wrap original container in several layers of newspaper and discard in trash.
