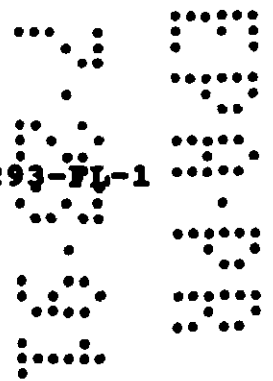

**PRECAUTIONARY STATEMENTS**

**Hazards to Humans and Domestic Animals**

**CAUTION:** Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs, and domestic water supplies. Wash thoroughly after handling. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only as specified on this label and cover food and food handling equipment and surfaces before treatment. Thoroughly wash dishes and food handling utensils if contaminated with this product.

**Environmental Hazards**

This product is extremely toxic to fish, birds and other wild life. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

**Statement of Practical Treatment**

**IF SWALLOWED:** Call a physician or Poison Control Center. Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

**IF INHALED:** Remove victim to fresh air and apply respiration if indicated.

**IF ON SKIN:** Wash promptly with soap and water. Rinse thoroughly.

**IF IN EYES:** Flush with plenty of water. If irritation persists, get medical attention.

**NOTE TO PHYSICIAN:** Chlorpyrifos is a cholinesterase inhibitor. Atropine by injection is antidotal only if symptoms of cholinesterase inhibition are present.

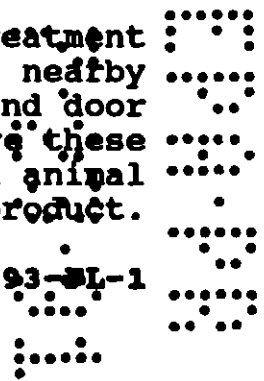
**DIRECTION FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**BROWN DOG TICKS AND FLEAS:** Apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these insects may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product.

**FLIES AND MOSQUITOES:** Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

**CONTACT SPRAY - KILLS AND REDUCES INFESTATIONS:** COCKROACHES, CRICKETS, SILVERFISH, CARPET BEETLES, CLOVER MITES, CENTIPEDES, MILLIPEDES, FIREBRATS, EARWIGS, SOWBUGS, ANTS, SPIDERS, FLEAS: Use as a spot treatment. When possible, spray directly on pests to reduce infestations. Apply as a coarse spray or with a paint brush into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators and other appliances, baseboards and storage areas. Apply spray until area is wet, but not to the point of run-off. Repeat as necessary.

**ANTS:** To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

**ATTENTION (PESTS INDOORS):** Do not apply this water-based product in conduits, motor housing, junction and switch boxes or other electrical equipment because of possible shock hazard. If there is need to treat such areas use only oil-base sprays. Prior to application, de-energize electrical equipment. After application, allow time for oil to evaporate before starting motors or placing switches in the "ON" position.

**STORAGE AND DISPOSAL**

Store in original container in a cool, locked storage area away from heat or open flame.

Do not reuse container. Rinse thoroughly before discarding in trash. Securely wrap original container in several layers of newspaper and discard in trash.
