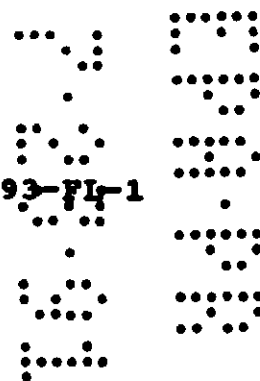

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs, and domestic water supplies. This product is extremely toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

Do not use, pour, spill or store near heat or open flame.

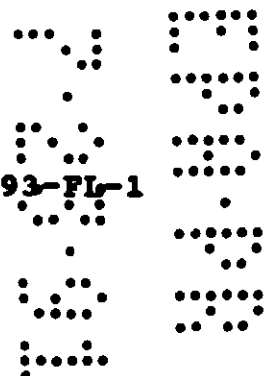
Statement of Practical Treatment

IF SWALLOWED: Call a physician immediately. If gastric lavage is deemed necessary, undertake if material was taken internally. Do not induce vomiting unless no other treatment is available. Vomiting may cause aspiration pneumonia. If necessary to induce vomiting, give 1 or 2 glasses water and insert finger to back of throat. Repeat until vomit fluid is clear. Contains a cholinesterase inhibitor. Atropine Sulfate is antidotal.

IF INHALED: Remove victim to fresh air and apply respiration if indicated.

IF ON SKIN: Wash promptly with soap and water. Rinse thoroughly.

IF IN EYES: Flush with plenty of water. If irritation persists, get medical attention.



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with labeling.

FOR SPOT APPLICATION ONLY: Use DURSBAN Household Insecticide as a spot treatment to control cockroaches, silverfish, spiders and other pests specified below. Apply as a coarse (large droplet) spray to localized areas where pests may occur. Spray surfaces until wet. Re-treat as needed.

Cockroaches, Silverfish, Spiders: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window sills and frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly.

Brown Dog Ticks: To control these pests, thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.

Flies and Mosquitoes: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

STORAGE AND DISPOSAL

Store in a cool dry place preferably in a locked storage area. Do not reuse this container. Rinse thoroughly, wrap in newspaper before discarding in trash.
