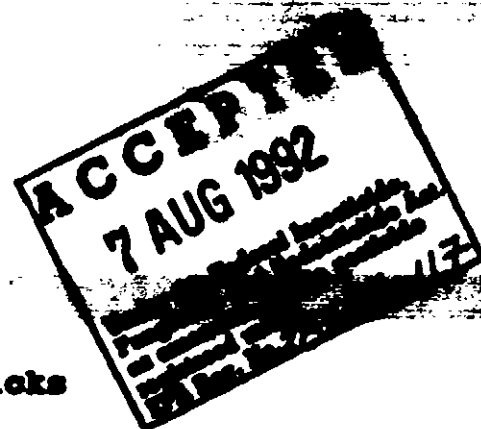

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed or inhaled. Avoid skin contact. Avoid inhaling. Avoid contamination of foodstuffs. Wash hands after applying. Do not exceed recommended dose. Do not spray directly on nursing kittens or puppies. Consult veterinarian at first sign of adverse reaction.

Physical and chemical Hazards

FLAMMABLE: Keep away from heat or open flame.

Statement of Practical Treatment

IF SWALLOWED: Do not induce vomiting. Call a physician or Poison Control Center immediately.

IF IN EYES: Flush with plenty of water. See a physician immediately.

IF ON SKIN: Wash with soap and water.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Kills and Repels: Fleas and Ticks

DOGS AND CATS: Direct the spray over the animal until the entire coat is slightly damp. On a heavily coated animal, ruffle the coat and spray against the lay of the hair. For best results in controlling ticks, spray directly on the tick. Thoroughly spray interior of kennel or other sleeping quarters. Repeat treatment as necessary. Do not spray structural surfaces where spotting, staining, or discoloration may be objectionable.

KITTENS AND PUPPIES: Treat same as dogs and cats, except for nursing kittens and puppies. Wrap the animal in a towel which has been sprayed lightly. Leave the nose and mouth exposed for normal breathing. Keep the animal wrapped for 5 to 10 minutes. Fleas may then be removed from the coat by picking or combing. Repeat as necessary.

STORAGE AND DISPOSAL

Storage: Store in original container away from heat or open flame.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.
