BEEF & DAIRY CATTLE: Horn Flies, Lice, Face Flies: Place contents of this package in any commercially available dust bag. Suspend bags in areas frequented by cattle or in gateways or lanes through which the animals pass daily for water, food, or minerals. Bags may also be suspended in loafing sheds or in front of protected mineral feeders. For lactating dairy cows, bags may be suspended in the exit through which cows leave the milking barn. In all cases the bags should be adjusted so that the bottom of the bag will hang four to six inches below the topline of the cattle. For reduction of face flies, the bags must be located so the animals will be forced to use them daily and hung at a height to insure that the faces of the cattle will be dusted.

Horn Flies, Lice - Direct Application: Apply 2.0 ounces of dust per animal by Shaker can over the head, neck, shoulders, back and tailhead. Repeat as necessary.

Bedding Treatment: Apply 2 ounces (6 level tablespoonfuls) uniformly over each 30 square feet of fresh, dry bedding by use of a shaker can or a suitable mechanical dust applicator. Repeat as necessary but not more often than once every ten days.

In severe infestations both individual animals and the bedding may be treated as directed above.

No interval is required between treatment and slaughter or between treatment and use of milk as food.

# STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Store in dry protected place to prevent cross contamination with other pesticides, fertilizers or feedstuffs. Preferable in locked storage area.

DISPOSAL: Completely empty bag into applicator equipment. Then dispose of empty bag in a sanitary landfill or by incineration. If burned, stay out of smoke.
