The amendment referenced above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable provided that you revise the product labeling in the manner described in this letter.

1. Create a new labeling section that is to be inserted directly under the "Precautionary Statements" and before the "Directions for Use" entitled "Statement of Practical Treatment". It should read:

"If Swallowed: Call a physician or poison control center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting. If in Eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If on Skin: Wash with plenty of soap and water. Get medical attention if irritation persists."

2. Revise the "Precautionary Statements - Hazards to Humans and Domestic Animals" section so that it reads:

"Caution. Harmful if swallowed. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. For external use on animals only. Not to be used on animals intended for food."

The registrant for the products in their line is now AgrEvo Environmental Health.
