2. Make the labeling change listed below before you release the product for shipment:

 - b. Revise Precautionary Statements by adding "...or inhaled" to the statement "Harmful if swallowed." Also, add "Causes moderate eye injury." before "Contains petroleum distillates."

TO OPERATE VALVE: Place several layers of newspaper or pad on a stand or table in the center of the room. Point valve opening away from face. To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. The place fogger on stand or table with valve locked open. Leave building at once and keep building closed for two hours before airing out. Open all door and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

3. On the Confidential Statement of Formula (CSF), please provide the upper and lower certified limits of the individually added ingredients (i.e., items 14 a. and b.).

4. You must submit a storage stability test on the formulated product. The product must be analyzed for its active ingredient at time zero and during a year of storage. The storage should be in warehouse conditions of temperature and humidity and stored in similar containers you will be using in trade. [Note: For the storage stability data, you cannot reference the concentrate you are using formulate your product.]

5. Submit 5 copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Harmful if swallowed. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs.

Remove pets, birds, and cover fish aquariums before spraying.

Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed.

Statement of Practical Treatment

IF SWALLOWED: Call a physician or Poison Control Center immediately. Do not induce vomiting because of aspiration hazard.

IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.

IF ON SKIN ON CLOTHING: Remove contaminated clothing and wash before reuse. Wash skin with soap and warm water. Get medical attention if irritation persists.

IF IN INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

Physical or Chemical Hazards

Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill cockroaches, confused flour beetles, crickets, fleas, houseflies, pill bugs, rice weevils, saw-toothed grain beetles, silverfish, small flying moths, spiders, ticks, and wasps.

Cover exposed food, dishes and food-handing equipment. Open cabinets and doors to area to be treated. Shut off fans and conditioners. Put out all flames and pilot lights. Close doors

and windows. Point valve opening away from face when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before reentry.

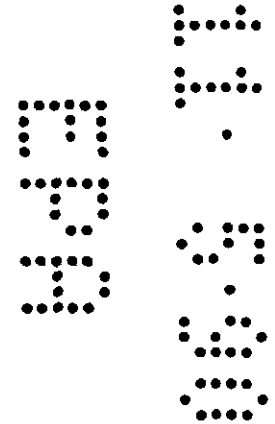
TO OPERATE VALVE: To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

To Kill Ticks and Fleas: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.

STORAGE AND DISPOSAL

Storage: Store in a cool dry area away from heat or open flame.

Disposal: Replace cap and discard container in trash. Do not incinerate or puncture.
