On the basis of information furnished by the registrant, the above named pesticide is hereby Registered/Reregistered under the Federal Insecticide, Fungicide, and Rodenticide Act.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) since you have agreed to:

1. Submit/cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling change listed below before you release the product for shipment:

a. Add the phrase, "EPA Registration No. 28293-192."

b. Revise the paragraph on the front panel (i.e., For Use In...) to read:

For use in homes, garages, kennels, offices,
and the nonfood/feed areas of food processing
plants, restaurants,...

[Note: In the above statement, qualify the site "hospitals" with "(non-occupied patient areas)."]

c. Revise the paragraph "Do not use in commercial food processing, ..." and replace it with the following precautions. These precautions should be added under the Directions for Use:

Do not use in the food/feed areas of food handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where foods may be prepared or held. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed.

Nonfood/feed areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries, and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

d. Use in food handling establishments can imply use in U.S. Department of Agriculture (USDA) Meat and Poultry Plants. Therefore, either add the statement "Not for Use in USDA Meat and Poultry Plants" or submit an application to USDA requesting use in these areas. If granted, you can then indicate on the label that the product can be used in these areas.

e. Revise Precautionary Statements by adding "...or inhaled" to the statement "Harmful if swallowed or absorbed through skin."

f. Add the following to the Precautionary Statements:

Do not apply this product in occupied patient rooms or in any rooms while occupied by the elderly or infirm.

Do not apply to classrooms when in use.

g. Since this product is for indoor/household use only, you may delete the Environmental Hazards statement.

3. On the Confidential Statement of Formula (CSF), please provide the upper and lower certified limits of the individually added ingredients (i.e., items 14 a. and b.).

4. Please submit the results of a one year storage stability study when available. The product must be analyzed for its active ingredient at time zero and during one year of storage. The storage should be in warehouse conditions of temperature and humidity and stored in similar containers you will be using in trade. [Note: For the storage stability data, you cannot reference the concentrate you are using to formulate your product.]

5. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Harmful if swallowed or absorbed through skin. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs.

Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed.

Remove pets, birds, and cover fish aquariums before spraying.

Do not allow children or pets to contact treated surfaces until spray has dried.

IF ON SKIN OR CLOTHING: Remove contaminated clothing and wash before reuse. Wash skin with soap and warm water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE

General: Use this spray as a spot or crack and crevice treatment to control cockroaches, flea, silverfish, ticks, waterbugs, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

FOR SPOT TREATMENT:

To Kill Ants, Black Widow Spiders, Carpet Beetles, Cockroaches, Crickets, Scorpions, Silverfish, Sowbugs, and Spiders: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, spray ant trails and around doors and windows, and wherever else these pests may find entrance. Repeat as necessary.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Pets should be treated with a registered flea and tick control product prior to reentering treated areas.

FOR CRACK AND CREVICE TREATMENT:

To Kill Ants, Black Widow Spiders, Brown Dog Ticks, Carpet Beetles, Cockroaches, Crickets, Fleas, Scorpions, Silverfish, Sowbugs, and Spiders: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where these insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food handling surfaces.

Flies and Mosquitoes: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the

home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry, place. Keep container closed.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.
