#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To control fleas, ticks and lice, wet dog's coat thoroughly with water. Pour shampoo into hand or onto dog, and rub into coat, starting with the head. Work backward until coat is completely covered with foamy lather. Let lather stay on 10 minutes, then rinse and towel dry. Keep away from eyes. Repeat once a week, as necessary.

### STORAGE AND DISPOSAL

STORAGE: Store in original container in cool, dry place.

DISPOSAL: If empty - Do not reuse this container. Place in trash or offer for recycling if available. If

partly filled - Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
