Dear Mr. Tharrington:

The Agency has reviewed your submission for a revised label, and the following comments apply:


- 1) You must specify under the product name that it is for Imported Fire Ant Mound Treatment only.
- 2) You must delete the container disposal statement "Securely wrap original containers in several layers of newspaper.....Wrap bag and put in trash" and you must use the proper container disposal statement for your container (the type of container was not specified on form 8570-1).
- 3) Use the term "First Aid" instead of Statement of Practical Treatment and you may choose to use the First Aid statement recommended by PR Notice 2000-3.
- 4)The text "keep children and pets off..." must be changed to "Do not enter or allow others to enter, including children and pets, until .....
- 5) Your statement of ".....until this material is washed into the soil and grass is dry" appears to contradict "do not water..." under the directions for use.
- 6) You must submit the final printed label before releasing the product to market.

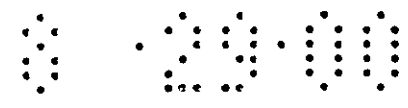

#### Hazards to Humans and Domestic Animals

**Statement of Practical Treatment**

Apply one-half cup (4 tablespoons) of **Unicorn Dursban 1.0%G Granules** to the center of the mound and out two feet surrounding it. Do not water in or disturb the mound. Apply when temperatures are between 65° and 80° degrees F. Treat new mounds as they appear.
