

Dear Mr. Santerre:

The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. provided you incorporate the Agency's condition as enumerated in this letter below and submit three copies of your final, printed labeling prior to releasing the product for shipment. A stamped copy of the current label is enclosed.

There is a unique "Environmental Hazards" statement required for chlorpyrifos enc-use products:

> "This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment washwaters."

Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. If these conditions are not complied with, your registration will be subject to cancellation in accordance with FIFRA Section 6(e).

PESTS OUT-OF-DOORS

<u>General Information:</u> Use <u>Dursban 1-12</u> insecticide for control of certain pests on outside surfaces of buildings and on lawns and ornamental plants, and for area control of ticks and chiggers. Consult the following directions for dosage and application details to control the pests listed.

<u>Pest on Outside Surfaces of Buildings:</u> Use **Dursban 1-12** at the rate of 5-1/3 fluid ounces per one gallon of water (0.5% chlorpyrifos emulsion) to control ants, clover mites, cockroaches, crickets, earwigs, fleas, flies, millipedes, mosquitoes, sowbugs, spiders and ticks by application as a residual spray or with a paint brush to outside surfaces of eaves, patios, garages, refuse dumps and other areas where these pests congregate or have been seen. Do not treat or allow the spray to contact plants (lawns, flowering plants, shrubs, trees, evergreens, etc.) because of possible injury. Repeat treatment as needed to maintain effectiveness.

NOTE: To help prevent infestation of buildings by ants, crickets, earwigs, millipedes, and sowbugs (pillbugs), treat a band of soil 6 to 10 feet wide around and adjacent to the buildings, also the building foundation to a height of 2 to 3 feet, where pests are active and may find entrance. Use 2 pints of **Dursban 1-12** per 100 gallons of water and apply as a coarse spray at the rate of about 10 gallons spray mixture per 1000 sq. ft. to thoroughly and uniformly wet the band area.

<u>Pests of Lawns and other Ornamental and Recreational Turf Grass Areas:</u> Use **Dursban 1-12** to control pests listed in the following table by application at the recommended dosages and in accordance with the directions given below. Dilute **Dursban 1-12** in enough water to obtain complete and uniform coverage of pest-infested areas and apply as a coarse, low-pressure spray using suitable application equipment. Thoroughly water immediately after treatment to wash the insecticide into the turf, except as noted. For best results, the lawn should be moist at time of treatment.

Pests of Ornamentals: Use Dursban 1-12 insecticide to treat flowers, shrubs, vines, shade and flowering trees and evergreens found to be infested with the pests listed in the following table. Dilute Dursban 1-12 with water according to directions given in the table and apply using suitable hand or power spray equipment in a manner to provide complete and uniform coverage. For best results apply a wetting spray to both upper and lower leaf surfaces and infested limb and trunk areas. Attempt to penetrate dense foliage but avoid overspraying to the point of excessive runoff. Treat when pests appear and repeat at 7 to 10 day intervals, if needed. NOTE: Do not use on azaleas, camellias, poinsettias, rose bushes, or variegated ivy because of possible injury to these plants.

<u>Dogwood Borer:</u> Apply **Dursban 1-12 to the trunks** and lower limbs of dogwood trees when the adults begin to emerge. Consult your State Agricultural Experimental Station or Extension Service specialist for proper time to treat in your area. Mix at the rate of one gallon of **Dursban 1-12** in 100 gallons of water and apply uniformly on trees as a coarse, low-pressure spray.

<u>Peach Tree Borer:</u> Apply **Dursban 1-12 to flowering** trees and shrubs of the Genus Prunus in water as a trunk spray before newly hatched larvae enter the trees. Apply as a coarse low-pressure spray. Thoroughly wet all bark areas from ground level to scaffold limbs. Consult your State Agricultural Experimental Station or Extension Service specialist for proper time to treat in your area.

EPA EST. NO. 62472-FL-1A 44616-MQ-1B Subscript used is first letter of run code on container. , NOTE: Mosquitoes coming to rest on areas treated for control of turf and ornamental plant pests will be killed for varying periods of time after treatment, depending on exposure of treated areas to weathering conditions.

Attention: Keep children and pets off treated areas until spray has dried. Keep out of lawn and garden fishpools and other bodies of water.

Native Elm Bark Beetle: (Prevention of Overwintering) To prevent the adult beetle from overwintering in uninfested trees and to reduce beetle populations in disease-free areas, apply Dursban 1-12 insecticide as a 0.5% mixture of chlorpyrifos in water to the bottom 9 feet of the trunk. Wet the trunk thoroughly but do not spray to runoff. Care should be taken to apply the spray right to the base of the root flare. Applications can be made with either a back pack mist blower or a hydraulic pressure sprayer from spring through to the early fall. (Prevention of Branch and Twig Feeding on High Value Elm Trees) To reduce the twig and branch feeding on uninfested trees deemed to be high in value apply 0.5% chlorpyrifos water spray to the tree crown. Application should be made in the spring or early summer using a sprayer that will give thorough coverage to the tree crown.

ATTENTION: Do not allow public use of treated areas during application or until spray has dried.

Area Control of Ticks and Chiggers: Use **Dursban 1-12** insecticide to control ticks and chiggers infesting non-cropland areas such as roadsides, footpaths and trails, picnic and camping sites, parks and other recreational areas where these pests are present and create a nuisance or possible public health problem. Apply **Dursban 1-12** in water at the rate of 2 pints per acre (equivalent to 1 fl. oz. per 2,700 sq. ft.) using a hydraulic sprayer, mist applicator, knapsack sprayer, or other suitable hand or power spray equipment. Treat low underbrush, grassy areas, weeds, and ground surface and debris using enough spray volume to obtain thorough coverage, usually 40 to 100 gallons per acre.

Treatment of fire ant mounds. Apply **Dursban 1-12** as a drench diluted at the rate of 2 fl. oz. (60 ml) per 2 gallons of water. Gently sprinkle a total of 1 gallon of the diluted solution over the surface of each mound using a sprinkler can. Thoroughly wet mound and surrounding areas to a 4 ft. diameter (12 sq. ft.). For best results apply in cool weather, 65-80°F, or in early morning or late evening hours. Treat new mounds as they appear. Pressurized sprays may disturb the ants and cause migration, reducing product effectiveness.

SUBTERRANEAN TERMITES - DIRECTIONS FOR HOMEOWNER USE TERMITE CONTROL AROUND EXISTING STRUCTURES Buildings with Basements or Crawl Spaces

First remove all wood debris and wood forms. Outside, around piers, pipes, chimney bases and along foundations of poured concrete, dig a trench 6 inches wide and 4 inches deep. For brick and block foundations, dig the trench about 12 inches deep. If footing is more than 12 inches deep, make holes with a crowbar, pipe or rod about 1 foot apart that extend from the trench bottom to the top of the footing. Make holes closer in hard-packed clay soils. NEVER DIG BELOW THE TOP OF THE FOOTING. Apply the emulsion (or solution) in the trench at a rate of 4 gallons per 10 linear feet per foot of depth. Apply half of this to the back-fill. This product should be applied as a 1/2% water emulsion. Mix 1 gallon of concentrate in 24 gallons of water to produce a 1/2% emulsion. Cover treated soil with a thin layer of untreated soil.

For raised porches, terraces and outdoor entrance slabs, drill holes at 1 foot intervals, 6 inches from the foundation, and pour ½ gallon of emulsion (or solution) into each hole. Refill holes. Slabs with heat ducts or radiating heat pipes, should be treated by a commercial pest control operator.

The object is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment, particularly if there are inaccessible areas, basements or slab-type construction. For severe infestations or treatment under slabs, in basements and buildings with crawl space, etc., contact a licensed pest control operator or termite control service.

Avoid contamination of public and private water supplies by following these precautions. Do not allow a hose or any type of faucet extension to reach into the termite chemical solution while filling or mixing this material with water. Use anti-back-flow or anti-siphonage equipment on all filling equipment. These devices can be purchased at hardware or plumbing supply stores. Use of anti-back-flow equipment will help to insure that the user of this toxic chemical will not contaminate domestic water supplies. Refer to Federal (Federal Housing Administration), State and local specifications for safe distances of treatment areas from wells. Soil in the vicinity of wells, cisterns or ponds should not be treated if it is water saturated, subject to excessive saturation due to an accumulation of water, or if the soil to be treated around the perimeter of the structure is at a grade lower than surrounding yard or property area. If this is the situation, apply as follows: DO NOT APPLY UNDER PRESSURE. Soil should be removed to an area safe from well or domestic water contamination, treated, allowed to stand undisturbed for 2-4 hours, then returned to the trench which has been lined with 4 mil. plastic sheeting. Be careful not to puncture the plastic sheeting when returning soil to the trench. Do not treat structures that contain cisterns or wells.

RETREATMENT RESTRICTIONS

- 1. Retreatment for subterranean termites should only be made when there is evidence of reinfestation subsequent to the initial treatment, or there has been a disruption of the chemical barrier in the soil due to construction, excavation, landscaping, etc.
- 2. Retreatments may be made to critical areas in accordance with the application techniques described above. This application should be made as a spot treatment to these areas.

Annual treatment of the entire premises must be avoided.
