## <u>Hazards</u> to <u>Humans</u> and Domestic Animals

# DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This spray kills fleas and ticks. It contains a unique combination of ingredients that kills both adult and preadult fleas. Even kills fleas before they grow up to bite. NYLAR, a unique ingredient in this flea spray, continues to kill fleas for 120 days (4 months) by preventing their development into the adult biting

stage. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, floor cracks. Protects your home from reinfestation and fleas buildup, your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectional odor or sticky mess and, used as directed, does not stain furnishings.

FLEAS & TICKS: SHAKE WELL. Hold can 2 or 3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture.
