DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

INTRODUCTION: This concentrate acts on the immature life stage of the flea, preventing the adult flea from developing. Flea eggs deposited on and Larvae crawling onto treated areas will not develop into adult fleas. Existing adult fleas and flea pupae are not affected.

If a high population of adult fleas (the biting stage) is present, the use of an adulticide may be necessary for immediate relief. For best results, use this Concentrate prior to the flea season. When applied to surfaces where fleas are found, such as carpets, upholstered furniture and pet sleeping areas, this product prevents adult flea emergence for 7 months (210 days).

Flea control on pets is important in prevention of introduction of adult fleas indoors. When using this product, and fleas are problems on pets, the pets should be treated with an effective registered flea control product to prevent the introduction of adult fleas indoors.

Method and Rate of Application: Prepare a diluted spray solution by adding 1 oz. of Unicorn IGR Concentrate to 1 gallon of water. Partially fill the mixing container with water, add the concentrate. Shake, and fill to final volume. Shake before each use.

Apply at a rate of 1 gallon of diluted solution per 1,000 sq. ft. of surface area with any low pressure sprayer typically used for indoor applications. Treat all areas which may harbor fleas, including carpets, furniture, pet sleeping areas and throw rugs. Treat under cushions of upholstered furniture. Avoid contact with treated surfaces until dry.
